Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Social Security number and income ■ Credit history and credit scores ■ Account balances and payment history <p>When you are <i>no longer</i> our customer, we continue to share your information as described in this notice.</p>
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Reynolds Buick Inc. chooses to share; and whether you can limit this sharing.

Who is providing this notice?

Reynolds Buick Inc., dba Reynolds Buick GMC Trucks, Reynolds Isuzu Trucks, Reynolds Buick GMC Isuzu.

What we do

How does Reynolds Buick, Inc. protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Reynolds Buick, Inc. collect my personal information?

We collect your personal information, for example, when you

- Show your driver's license or Give us your contact information
- Apply for financing or Apply for a lease
- Provide employment information or use our website.

We also collect your personal information from others, such as credit bureaus, affiliates or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Jireh Reinsurance Ltd.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Non-affiliates we share with can include General Motors and Isuzu, their vendors; other finance institutions to which we may seek to assign your contract or lease and their vendors.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *e. g. GM Financial, Isuzu Finance or Ally Bank.*
